Stabilise N Fertiliser

We focus on reducing the negative impact of ammonia and greenhouse gases in our environment.

Nitrous oxide (N₂O) is 300 times more harmful than carbon dioxide, and agriculture is one of the largest contributors responsible for N₂O emissions internationally.

Farmers can reduce their N₂O emissions footprint in a number of ways:

- Decreasing the amount of fertiliser applied, which risks yield loss.
- Using enhanced fertiliser that reduces emissions loss and enables that reduction with no yield impact.

Verdesian has products that stabilise N fertiliser, to support the reduction of ammonia and greenhouse gases, and enable producers to grow more food, sustainably.

Fertiliser Use Efficiency

We focus on improving water quality.

We do this by reducing leaching into the groundwater from fertilisers which wastes resources and changes water quality, hence creating phosphorus fertiliser enhancer.

We keep more nitrogen in the crop root for longer, with such products developed with our Nitrogen Use Efficiency Technology, allowing plants to absorb more of the nutrients they need.
